I hereby apply for service or services indicated at the premises noted herein, and promise to purchase any pay for same in accordance with the schedule of rates which shall from time to time be legally in effect, and to conform to and abide by the Company's rules and regulations in force to the purchase and sale of said service(s). This contract for gas service shall at all times be subject to changes or modifications by the Public Utilities Commission of the state of California (CPUC) as said Commission may from time to time direct in the exercise of its jurisdiction, Tariff Rule No. 5.

It is mutually agreed and understood that the ownership of the main, service line and meter will shall vest with in Alpine Natural Gas, who shall assume operation and maintenance thereof. The Utility will at all times have right of ingress to and egress from the customer's premises at all reasonable hours for any purpose reasonable connected with the furnishing or termination of gas service.

Applicant agrees to pay all bills in accordance with the Company's terms of sale. Should suit be brought or legal action be taken by an attorney on same for collections, applicant promises to pay a reasonable fee for such action, including all costs of court and attorneys' fees to the extent found by the court to be reasonable under the circumstances.

It is agreed Alpine will install (where an existing service line does not exist), own, operate and maintain its gas facilities up to 100 feet from the main and will (if needed) install an extension of its gas distribution system under the terms of the CPUC in accordance with the provisions of Rule No. 16, gas service extensions and facilities on customer's premises. In the event that the applicant disconnects service within (12) months of Alpine's installation of gas facilities, applicant agrees to pay for such facilities in accordance with the provisions of Alpine's Tariff Rule No. 13, regarding temporary service. **A \$30.00 fee to initiate service must accompany this application.**
